Privacy Statement

In this privacy statement, we want to provide clear and transparent information about what data we collect and how we handle personal data. Personal data

Asking for your explicit consent if we need it for processing your personal data,

Have taken appropriate technical and organizational measures to ensure the security of your personal data,

Not to pass on personal data to the other parties, unless this is necessary for carrying out the purposes for which they were provided,

to be aware of your rights regarding your personal data, to make you aware of them and to respect them.

We do not provide personal data to parties located outside the EU.

In the event of a sale, merger, reorganization, restructuring, dissolution, or similar event relating to the companies' business or assets, your personal data may form part of the transferred assets.

You have the right to object to the above and the firms will no longer process this information upon your request.
